### Programme description

#### Expected impact:

Better livelihoods and gender inclusion for people working along the Development Minerals value chain in OACP countries.

#### Expected outcomes:

Increased employment and income for artisanal and small-scale mining enterprises in particular increased economic opportunities for women participating in ASMEs.

#### Expected outputs:

1. Enhanced capacity of governments, regional institutions and organisations to strengthen the business enabling environment for operators in the Development Minerals value chains;
2. Improved geological systems with Development Minerals geodata that is also open and publicly accessible;
3. Enhanced entrepreneurship skills to strengthen value chains in the Development Minerals;
4. Strengthen capacity of regional institutions and organisations, universities, colleges and vocational training centres to provide training and applied research to support ASMEs in development Minerals;
5. Enhanced understanding and awareness of key stakeholders on innovation and technological advancements in the nexus between Development Minerals and sustainable development.
6. Increased availability and accessibility of financial products, including small grants, to the Development Minerals sector;
7. Increased promotion of locally produced Development Minerals products with ACP countries and internationally;
8. Increased knowledge and awareness of environmentally and socially responsible mining and its monitoring;
9. Improved environmental and social operating standards among ASMEs;
10. Gender mainstreaming and support to women in the Development Minerals sector is improved;
11. Institutional support and South-South cooperation and knowledge exchange on development Minerals is expanded.
12. Institutional set-up of the African Minerals Development Centre (AMDC) in support of the African Mining Vision and the AfCFTA to promote and support the sustainable development of the ASME/ Development Minerals sector.

**Governance Steering Committee:** Provides oversight and will be responsible for making, by consensus, strategic and management decisions guiding project implementation.

- The Project Management Team consists of staff members in Brussels, Addis Ababa and in the programme focus countries.

**Geographic coverage:** All OACPS countries (Africa, Caribbean, Pacific)

- **In-Depth Focus Beneficiary Countries:** Burkina Faso, Cameroon, Congo, Fiji, Guinea, Jamaica, Uganda, Suriname, Zambia.
- **Technical Training and Capacity Building:** 41 countries across OACPS Regions.

**Target Beneficiaries:**

**Public stakeholders:** Relevant ministries and government agencies - particularly those that regulate and set policies for minerals exploration and exploitation, environmental and safety standards, private sector development and the financial sector. Local government authorities. **Private stakeholders:** Artisanal and small-scale mining and quarrying enterprises, and other enterprises in their value chains.

**Business development stakeholders:** Mining and quarrying associations (including women's mining associations); chambers of mines; training centres; universities and research institutions; financial institutions.

**Communities and social stakeholders:** civil society groups and local communities; civil society, advocacy groups, local and traditional leaders and non-state actors.
